

PAYMENT OF THE RESERVATION FEE

In order to formalize the registration, the amount of 1.000 € must be paid at the time of inscription or within a maximum period of 10 days, otherwise Gaia-Camp reserves the right to freely dispose of the camper's place. IN THE EVENT OF CANCELLATION AFTER MARCH 31st, THE RESERVATION FEE WILL NOT BE REFUNDED. Cancellations must be confirmed by email the week before March 31st, otherwise the established deadlines will apply. Payment can be made at our offices by bank cheque, cash, or bank transfer **indicating the name of the holder and the name of the child in the concept of the transfer.**

REGISTRATION FORMALISATION

In order to finalise the registration and confirmation of your child's place at Gaia Camp, it is compulsory to pay the outstanding amount. We will send you a personal email or an App notification indicating the amount to be paid in each case. **Payment must be made within 10 days of receipt of the email/notification.**

FORM OF PAYMENT

Both payments can be made at our offices by bank cheque, cash or bank transfer **indicating the holder's name and the student's name as concept of the bank transfer.**

CANCELLATION OF REGISTRATION

The camper's place will be only confirmed once the second payment has been made. No reimbursement will be made except in the case of force majeure or duly justified causes, such as: death of a family member, surgery or medical reasons that prevent the child's participation in Gaia Camp.

Should anyone decide to cancel a child's participation in camp, Gaia Camp must be notified in writing together with documentary proof of cancellation. For all purposes, the date of receipt of this notice will be the reference date for establishing the cancellation deadlines indicated below. For several years now it is possible to take out an additional insurance plan (at extra cost) which, I believe is advisable as it covers different cancellation and refund causes.

We consider the starting date of Gaia Camp as July 1, 2023.

Cancellations after March 31st: the entire reservation fee will be retained.

- Cancellations prior to May 1st: the entire reservation fee will be retained and the second payment will be refunded in full.
- Cancellations between May 1st and May 30st: the entire reservation fee will be retained together with 25% of the second payment as administration fee.
- Cancellations between June 1st and June 15st: the entire reservation fee will be retained together with 50% of the second payment as administration fee.
- Cancellations after June 15st (included): 100% of the total amount invoiced will be retained as a cancellation fee.
- Once the camp has started, if a participant decides to leave the camp for any reason, with the exception of force majeure, the amount paid will not be refunded.

Cancellation Policy due to Covid 19

Gaia Camp will inform promptly of the decisions and regulations that may be decided or implemented in each case by the Competent Authorities. Only in case Health Regulations prevent the activity from being carried out, Gaia Camp will fully refund the second camp payment and 50% of the reservation fee for those who do not wish to keep it for the next camp. However, parents will be duly informed about the **possibility of signing an insurance policy covering this type of contingency.**

Among the causes of force majeure included in this document, COVID 19 is not included in any case, whether because the student comes infected to the camp or because has developed symptoms in the camp.

Regarding sanitary measures and tests to be done by Gaia Campers and companions, I consider more prudent to inform parents according to the current circumstances of the situation. I assure you that I will be punctually updated by specialists in the field, to be able to assist and guide you throughout this process and thus ensure the safety of everyone who is part of Gaia Camp.
